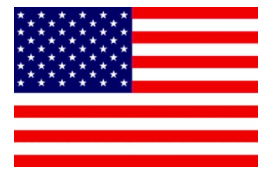
HOUSE COMMITTEE NEWS

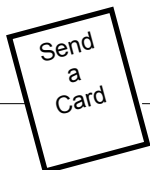

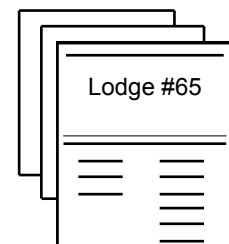

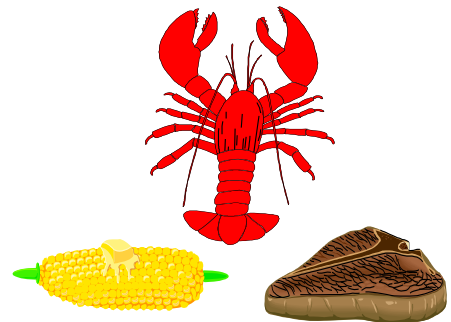
