There will be a short service at 10:00 AM

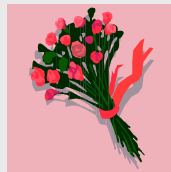

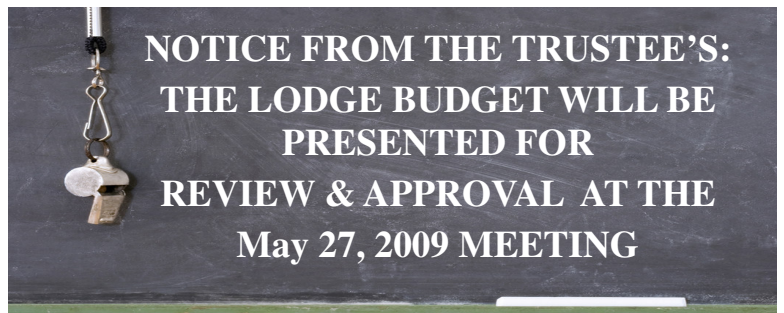

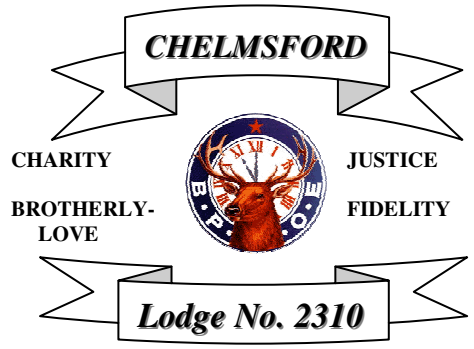
